## THE BACKDROP

Taking a simplistic view of the matter, one may have an impression, that the justice administration is only just a following of few practices, procedures and routines. But what is the real process that can really make the system attain the goals of desired level of satisfaction for consumers of justice and a true support to citizens of the country expecting nothing less than unremitting good governance. It is a million-dollar question. It would not be totally untrue to assume that, seen uncritically, a largely engaging system of justice is in place on the ground, though with few reservations. At the same time, the system needs well trained, skilled and brainy lawyers who can enrich the profession of law and carry the system to the next level of satisfaction.

There is a truism that most of the new lawyers generally are disadvantaged in getting not sufficient learning/training in their law schools/faculties on finer aspects of the case processing, procedural and auxiliary laws.

Special research and communication skills, required by lawyers, are also seen mostly not expectedly ingrained. In our stance to get to new levels of development of the system as well as the individuals, the judicial system should not be left to look dependent on customarily trained performers (lawyers and judicial officers) who are actually left to learn only by observation in the justice system.

#### **GET EQUIPPED BETTER AND CHANGE THE MILIEU**

Due to the existing nature of the legal education in the country (especially due to corona period challenges) the professionals are more absorbed in traditional and routine practices only. The young lawyer needs support in terms of better knowledge of finer aspects of law, special practices in courts and procedural laws. Absence of targeted learning hampers the individual grooming into a good performing lawyer as well as delivery of justice. As no citizen, especially young lawyers, should remain complacent to the inadequate working of any establishment. There is an urgent need to break the inertia, change the ground situation and resort to vibrancy, vivacity and exuberance.



## **QUEST FOR EXCELLENCE**

The new entrants to the system and young professionals of law possess enough talent to grow into most versatile and proficient advocate with extraordinarily talent and competitive performance. We can plan for excellence!

Though we would opt to be uncritical of the system, the big picture demands effective action in improving professional qualities of new and young lawyers to contribute to excellence, not only in ordinary courts but also in consumer courts, special tribunals and mediation and arbitration processes. These realities, inter alia, call for looking into the system beyond the instant.
