LLB

Bachelor's degree in any discipline from a recognised university in India or abroad.

LLM

LLB degree from a recognised university with merit based on CLAT PG /CUET (PG) or any other equivalent entrance examination.

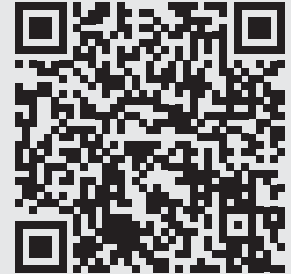
